## Parents' Bill of Rights in Louisiana Schools

Original Bill, Act 699 of 2014 This bill recognizes that:

- Parental involvement is a significant factor in increasing student achievement and that access to student information encourages such involvement

Original rights included in Act 699. (R.S. 17:406.9)

1. The right to examine textbooks, curriculum, and supplemental material used in their child's classroom
2. The right to inspect their child's school records, including:
  - a. Academic records
  - b. Medical or health records
  - c. Records of any mental health counseling
  - d. Records of any vocational counseling
3. To be notified when medical services are being offered to their child, except where emergency medical treatment is required.
  - a. In cases where emergency medical treatment is required, the parent shall be notified as soon as practicable after the treatment is rendered
4. The right to be notified if a criminal action is deemed to have committed against their child or by their child.
5. To be notified if law enforcement personnel questions their child, except in cases where the parent has been accused of abusing or neglecting the child.
6. The right to be notified if their child is taken or removed from the school campus without parental permission.
7. To receive written notice and the option to opt their child out of any surveys that include questions about any of the following:
  - a. The students' sexual experiences or attractions.
  - b. The student's family beliefs, morality, religion or political affiliation.
  - c. Any mental health or psychological problems of the student or a family member.

Act 547 of 2018 Revised Parent's Bill of Rights:

1. Receive a child's education records within 10 business days of submitting a request.
2. Access the final school calendar for the academic year at least 30 days prior to the first day of school.
3. View a complete listing of school fees and the purpose of each.



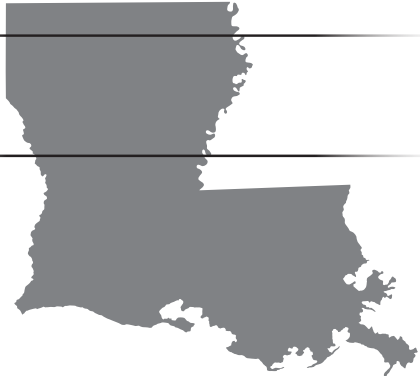

4. View any school uniform requirements on the school website.
5. Be promptly informed if their child is at-risk of not being promoted to the next grade level.

# قانون حقوق الآباء و الأمهات في المدارس العامة معدلة في 1 أغسطس, 2018

أولياء الأمور ، إن مشاركتكم في تعليم طفلك هو عامل مهم في زيادة إنجازه . و بما أننا شركاء في هذا العمل معًا ، فأنت تستحق أن تعرف حقوقك . يحدد قانون الحقوق الخاص بولاية لويزيانا حقوقك التالية :

- أن تفحص الكتب المدرسية ، المناهج الدراسية ، و المواد الأخرى المستخدمة في غرفة صف طفلك .
- أن تفحص سجلات مدرسة الطفل و الحصول على سجلات تعليم الطفل في غضون 10 أيام عمل من تاريخ الطلب .
- أن يتم إخطارك عند تقديم الخدمات الطبية .
- أن يتم إبلاغك بالإجراء الجنائي المتخذ ضد طفلك أو بسبب طفلك .
- أن لا تميز المدرسة ضد طفلك بناء على معتقدات دينية صادقة لعائلة الطفل .
- أن تتلقى إشعار خطي و خيار الانسحاب من الاستطلاعات التي تطرح أسئلة معينة .
- أن تحصل على التقويم المدرسي النهائي قبل 30 يومًا على الأقل قبل بداية السنة الدراسية .
- أن تراجع قائمة كاملة لجميع الرسوم المدرسية و الغرض من كل منها .
- أن تراجع متطلبات المدرسة في الزي المدرسي على الموقع الإلكتروني للمدرسة .
- أن يتم إبلاغك بسرعة إذا كان طفلك عرضة لخطر عدم الترقية إلى مستوى الصف التالي .



# PARENTS' BILL OF RIGHTS FOR PUBLIC SCHOOLS

Parents, your involvement in your child's education is a significant factor in increasing his or her achievement. As we are partners in this work together, you deserve to know your rights. The Louisiana Parents' Bill of Rights outlines your following rights:

- To examine textbooks, curriculum, and other materials used in your child's classroom.
- To inspect child's school records and receive a child's education records within 10 business days of the request.
- To be notified when medical services are offered.
- To be notified of criminal action taken against your child or by your child.
- That the school shall not discriminate against your child based on sincerely held religious beliefs of the child's family.
- To receive written notice and the option to opt out of surveys asking certain questions.
- To access the final school calendar at least 30 days prior to the beginning of the school year.
- To view a complete listing of all school fees and the purpose of each.
- To view any school uniform requirements on the school's website.
- To be promptly informed if your child is at risk of not being promoted to the next grade level.
