### **DISCUSSION ITEMS:**

- 4) Academic Report District Academics Updates
  - a) Ms. Brown shared updated demographic information and discussed ongoing efforts to recruit and retain certified staff. She provided an overview of tuition reimbursement programs and partnerships with Reach University to support teacher certification.
  - b) Ms. Brown also shared details regarding student demographics and needs, including uniform requests, which have been addressed through vouchers and the school's in-house uniform supply. Additionally, some families have requested shelter and food assistance; the district has been able to respond to several of these needs through the VDLE school pantry.
  - c) Board Comments & Discussion
    - i) Claricke Kirkland suggested that the Board purchase additional uniforms, noting that costs range between \$20–\$30 each.
    - ii) Dr. Tara Johnson commented that the food supply is currently limited.
    - iii) Maya Edwards recommended partnering with a social worker to identify specific family needs, including uniform sizes and other supports.
  - d) Academic Goals & Accountability
    - i) Ms. Brown highlighted the district's academic goals, which focus on student growth and align with the new state accountability rubric.
      - She noted that under the new system, proficiency expectations have increased, shifting from the *Basic* level to the *Mastery* level.
    - ii) For high school students, key performance indicators include:
      - (1) Graduation rates within four years
      - (2) Participation in Dual Enrollment
      - (3) Completion of Advanced Industry-Based Credentials
  - e) Important Dates
    - i) End of First Quarter: October 3
    - ii) Interim Assessments: September 29 October 2
    - iii) Fall Literacy Night: November 13
  - f) Board Questions
    - How many students are currently enrolled in Dual Enrollment courses?
      A: 12 students.
    - ii) Board Comment: The Board requested that a three-year pathway toward earning an associate











degree be developed for interested students.

- g) Board Feedback & Recommendations
  - The Board encouraged staff to explore student interests and identify opportunities to make their educational experience more engaging and memorable, to enhance word-of-mouth promotion among peers.
  - ii) It was noted that social media engagement has slowed, but the Board acknowledged that a Marketing Coordinator is being hired to address this.
  - iii) Highlight: "Tell your story—because nobody else is going to do it for you."
- h) The Board commended the schools for their continued efforts and expressed appreciation to faculty, staff, and attendees for their ongoing commitment and participation.
- 5) Finance Report Monthly Financial Statements
  - a) Year-End Summary:
    - i) Einstein Charter Schools continues to maintain strong and healthy financials.
  - b) Cash Flow Projections:
    - i) The organization currently holds a strong chance balance.
  - c) Budget vs. Actuals:
    - i) The budget was originally projected to break even; however, actual performance exceeded expectations. Although a fund balance drawdown had been anticipated, it was not necessary.
  - d) Annual Fiscal Comparison:
    - i) Revenue: Decreased slightly from the previous fiscal year.
    - ii) Expenses: Managed effectively, contributing to the positive year-end outcome.
    - iii) Overall: The district remains in a stable financial position, with no reliance on reserve funds.
